The Bank may rely on this certification; all statements contained herein are and will continue to be true and correct unless the Bank receives written notice to the contrary, and such additional documentation as the Bank may require. The Bank is not required to inquire whether the Trust Agreement has been changed, modified, altered, amended or rescinded, in whole or in part, whether the above named Trustee(s) continue to act in such capacity or whether any additional or successor trustee(s) has/have been appointed, or whether the above named person(s) continue(s) to have the powers to act as certified herein. The Bank is not required to assure the proper application of trust assets paid or delivered to or upon authorization of any Trustee.
14. The Trust Agreement has not been modified, amended or revoked in any manner which may cause any of the above certifications or statements to be untrue or misleading. I/We agree to notify the Bank of any modification, amendment or revocation of the Trust Agreement, in whole or in part, which would affect any of the above statements.
15. If an exhibit describing real estate or any interest in real estate is attached hereto, this Certificate may be recorded with the county recorder for the county in which such property is situated.

To the fullest extent permitted by applicable law, I/We shall indemnify and hold harmless the Bank, its subsidiaries and affiliates and their respective directors, officers, agents, employees and stockholders for, from and against any and all claims, judgments, suits, losses, costs, damages and expenses (including reasonable attorneys' fees) and any other liability or demands resulting from or in any way related to any statement contained in this certification being false, incorrect or incomplete or the Bank's acting on or relying upon this Certification of Trust and Indemnity.
