

## TRUTH-IN-SAVINGS DISCLOSURE ADDENDUM

**CHECKING ADDENDUM:** The following disclosures are provided to supplement the Truth-In-Savings Disclosure for your new Flagstar Checking account.

## **Refer-A-Friend Checking Account Terms & Conditions:**

The person making the referral (Referrer) will earn a \$50 Visa® Reward Card for each individual referred (Referred Person) to Flagstar Bank who registers for the offer using the Referrer's shared referral link, opens a new, eligible Flagstar Bank personal checking account within 180 days of completing the offer registration, and completes the offer requirements within 90 days of account opening. The Referred Person must be a new personal checking account customer of Flagstar Bank. The Flagstar Referral Program is available with Flagstar Ready Checking, Flagstar Elite Checking, Flagstar Student Checking, Flagstar Military Checking, and Flagstar One Checking.
